The college has four Academic Buildings and Separate Hostel facility for both Boys and Girls.

### ARTICLE I: PURPOSE

- 3.2 The modalities of this MoU may be amended at any time with the mutual consent of the Parties in writing.

### **ARTICLE IV: SPECIAL PROVISIONS**

- 4.1 Modalities of each type of collaboration, associated activities and financial aspects shall be mutually agreed upon on a case-by-case basis as per the guidelines issued by UGC from time to time.
- 4.2 This Memorandum of Understanding shall be governed and construed under the law of the Vijayawada, A.P., and Government of India depending upon where the activities take place.
- 4.3 The two parties will consult with each other and attempt to resolve disputes or misunderstandings that arise in the administration of this MoU or any subsequent associated agreement informally. Any dispute, controversy or claim arising under, out of or in connection with agreement shall be settled amicably.
- 4.4 Neither Party shall be liable for any unforeseeable event beyond its reasonable control caused by the fault or negligence of such Party, which causes such Party to be unable to perform its obligations under this Agreement, and which it has been unable to overcome by the exercise of due diligence. In the event of the occurrence of such a force majeure event, the Party unable to perform shall promptly notify the other Party. It shall further use its best efforts to resume performance as quickly as possible and shall suspend performance only for such period of time as is necessary as a result of the force majeure event.




